Stakeholders should ensure patients are educated in understandable and accessible ways about their condition and treatment options. They must be provided with information that is simple, relevant and comprehensive.

## **Partnership and collaboration:**

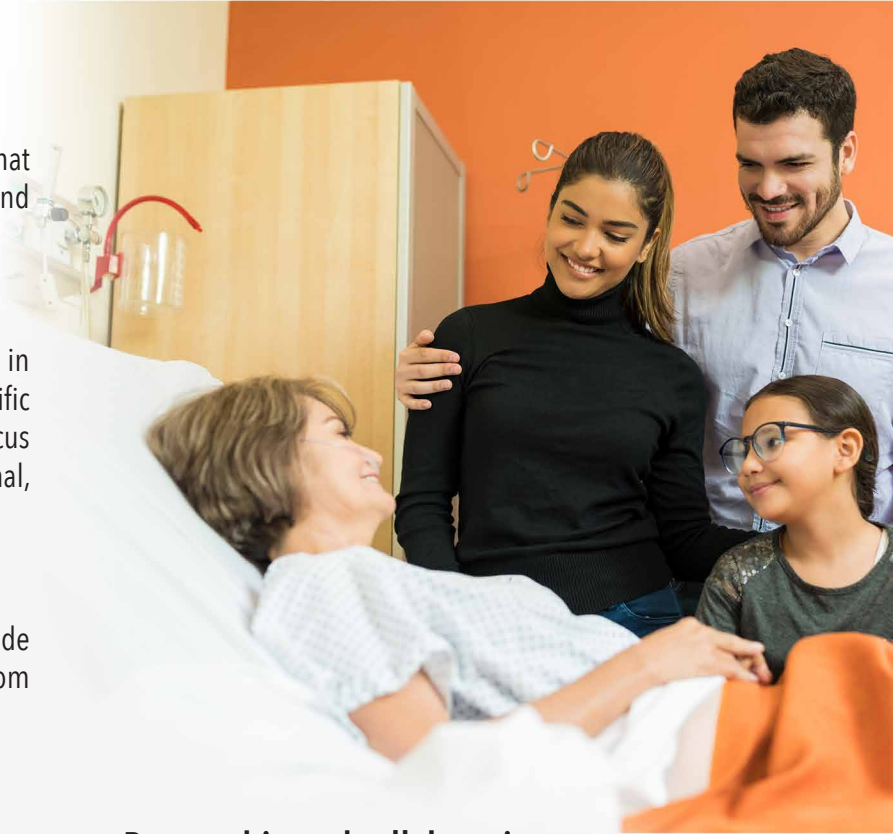
Patients should partner and collaborate with all stakeholders for the provision and access to safe, quality, and affordable healthcare.

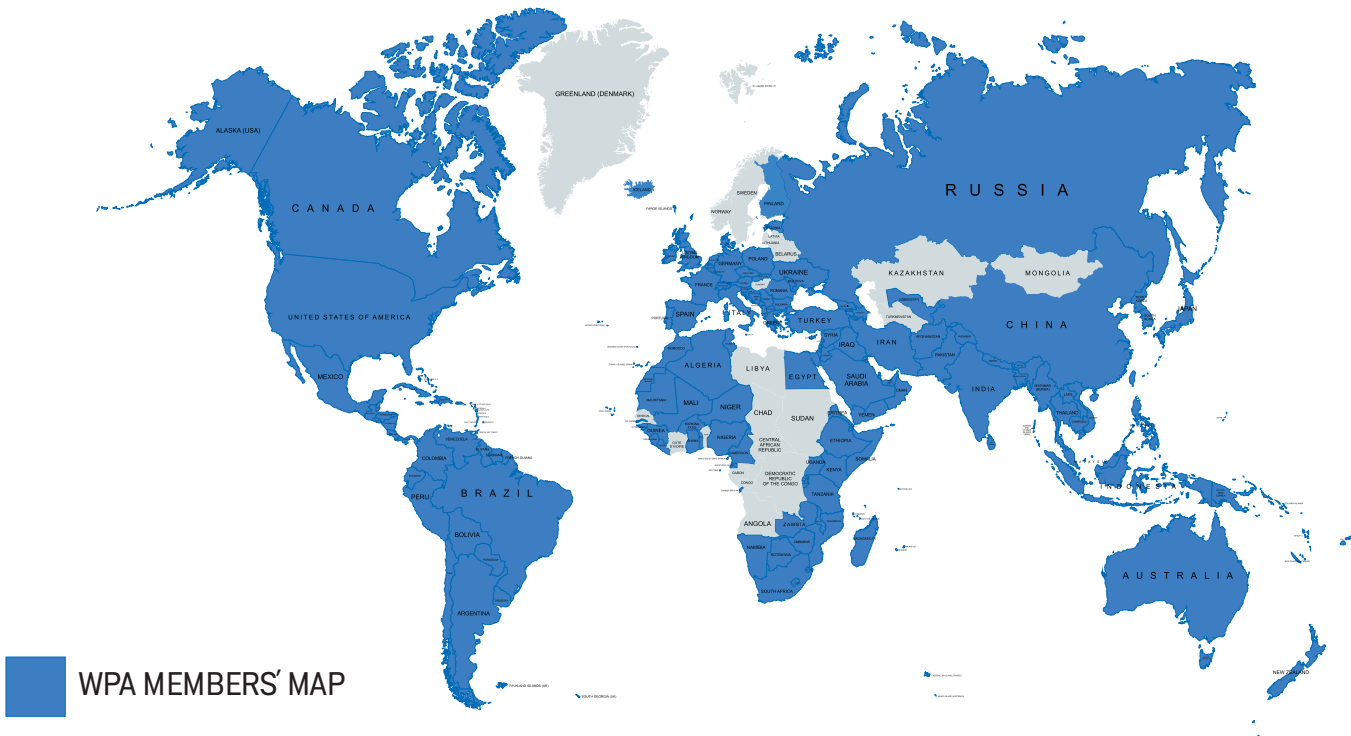
## **Patient engagement:**

The event participants presented and discussed the underlying issues of why over 615 million people in Africa cannot access essential services and why the services available are of very low quality and why is there a low sense of ownership and trust in the health care systems. Participants presented on current interventions that addressed barriers to quality health care. Based on the knowledge sharing and learnings during the event, the regional meeting participants' established a road map to bring patients and community organizations,

healthcare providers, and other healthcare stakeholders to partner and start contributing to the Universal Health Coverage framework of actions to achieve quality and safe care for African patients, families, and communities.

The meeting resulted in the establishment of a strong platform and network where patient organizations and partners can collaborate to foster interventions for patient engagement and empowerment to achieve quality and safe care in Africa.

# SURVEY 2022

WPA conducts annual membership survey to know exactly what our members needs are and how can we best serve them? All the yearly activities are designed keeping in view the results of the annual survey to ensure that we are actually delivering on what the patient organizations needed. The results of the WPA Membership Survey 2022 showed an excellent response with over 62% of WPA members responding by completing the online survey.

## THE KEY FINDINGS OF THE SURVEY SHOWED:

1. WPA Member Organizations represented hundreds of millions of patients globally
2. 94% said advocacy was a priority and over 52% of those respondents' requested assistance from WPA in advocacy efforts
3. 100% said awareness was a priority and over 41% of those respondents' requested assistance from WPA in awareness efforts
4. 95% said fundraising was a priority and over 76% of those respondents requested assistance from WPA in fundraising efforts
5. 85% said access to health care was a priority and over 68% of those respondents requested assistance from WPA in access to health care efforts
6. 98% said information to patients and families was a priority and over 40% of those respondents' requested assistance from WPA in information provision
7. 96% said education of patients was a priority and over 48% of those respondents' requested assistance from WPA in education of patient's efforts
8. 94% said education of health care providers (HCP) was a priority and over 72% of those respondents' requested assistance from WPA for educations of HCP efforts
9. 97% said capacity building of the organization was a priority and over 71% of those respondents' requested assistance from WPA for capacity building efforts
10. 80% said universal health care was a priority and over 72% of those respondents' requested assistance from WPA in universal health care efforts

# HTA SURVEY

Health Technology Assessments (HTAs) can provide crucial information regarding multiple aspects of healthcare that can have a positive impact on the lives of patients – if the patient voice is heard.

A properly developed assessment process can favor the establishment of a truly patient-centered healthcare system that covers quality and safety comprehensively and promotes a 'Get it Right the First Time' culture. WPA believes that patients must have access to healthcare that includes timely, safe, effective, affordable, optimal, nondiscriminatory and innovative treatments, health services, health devices, health products and pharmaceuticals.

WPA conducted a survey of its members and patients to understand what their experiences and thoughts were on health technology assessment (HTA). The survey was held in five languages that included English, Spanish, French, Dutch, and German languages. We had a total of 543 responses received online.

## THE KEY FINDINGS OF THE SURVEY SHOWED:

1. Cost of new medicines major concern across all countries
2. More than 50% were most concerned about the cost of new medicines
3. More than 70% say their government had not reach out to their organization regarding the state of healthcare
4. Limited involvement in the decision-making process with health care systems. In the Spanish speaking countries, the majority felt they were not involved
5. 80% agreed that treatment preferences could be better addressed by health care system



# World Patient Safety Day 17 September 2022

## “MEDICATION SAFETY”

Slogan was “Medication Without Harm” and the key action areas are high-risk situations, transitions of care, and polypharmacy.

The objectives of WPSD are to increase public awareness and engagement, enhance global understanding, and work towards global solidarity and action by all stakeholders to improve patient safety. WPA provided Grants to WPA member organizations to celebrate the day.

We all get sick, at some point in our lives, take medications to prevent or treat illness. However, if incorrectly stored, prescribed, dispensed, administered, or monitored, medications can be dangerous.

Medication errors are a leading cause of avoidable harm in health care globally. Medication safety incidents happen because of weak medication systems and human factors and can result in patient injury, disability and even death.

# WORLD PATIENT SAFETY DAY WEBINAR

The WPA World Patient Safety Day webinar was held on 14 September 2022. The topic was "Patient Engagement in Medication Safety," focusing on what patients can do to help keep themselves safe while using medications. This was in keeping with the 2022 World Patient Safety Day theme "Medication without Harm" and the long-running WHO global patient safety challenge on medication safety. Both these WHO campaigns were undertaken in acknowledgement of the fact that adverse events from medications are one of the greatest sources of patient harm in healthcare. Leading medication safety experts globally were the resource persons at the webinar.

To recognize World Patient Safety Day, WPA gathered four of the world's leading experts on medication safety that included Alpana Mair, Head of Prescribing and Therapeutics for Scottish Government and a global expert on the simultaneous prescription of multiple medications, Dr. Michael Cohen, head of the US Institute for Safe Medication Practices, Professor Phillip Routledge, Cardiff University, UK and Dr. Helen Ndagije, Director of Product Safety at the National Drug Authority of Uganda. Helen Haskell, WPA Patient Safety Committee member and chair of the Patients and Public Working Group of the global challenge moderated the webinar.

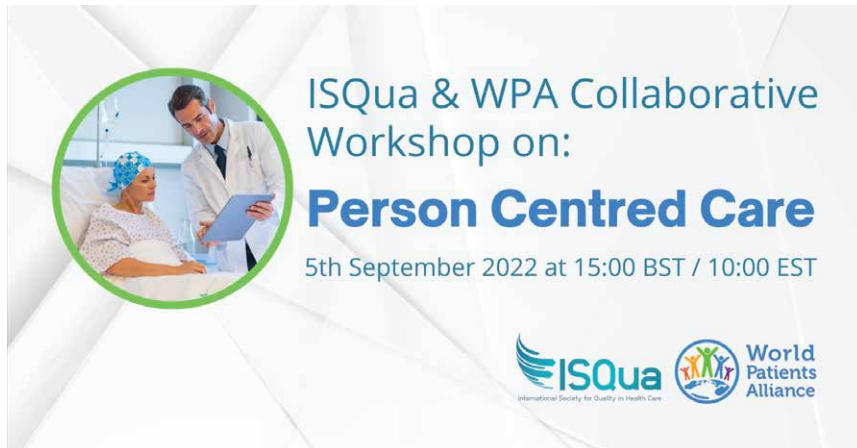

# BIOSIMILARS TRAINING PROGRAM



A Biosimilar Training Program was held from 10-11 May 2022, which educated patient advocates from all over the world on the health and economic benefits of biosimilars as well as the challenges they create for patients. The WPA partnered with the Global Colon Cancer Association and the Alliance for Safe Biologic Medicines for providing this extensive training program. This virtual event was open to patient advocates worldwide, representing all disease areas and attended by experts including physicians, pharmacists, regulators, and manufacturers. Patient advocates from around the world also shared their advocacy stories and strategies.

The training program highlighted how biologicals offers significant benefits and enhanced quality of life for patients with chronic diseases. However, finding a working treatment regimen may take a long time and involves trial and error for a patient's individual case. Nevertheless, government policies that force biosimilar switching for non-medical and strictly economic reasons may affect patients' treatment and their well-being, create mistrust in the healthcare system, undermine competition, increase total healthcare costs, and function as a barrier to innovation and future access to new biological drugs for patients. The attendees were taught how to collaborate with allies, identify champions, make clear policy request, build long-term relationships with policymakers, stay informed and keep your members engaged. The participants were also provided extensive training on the Biosimilars Patient Advocacy Toolkit which includes definitions, questions for your doctor, sample position statements for your organization, sample letters to policy makers, and much more

# COLLABORATIONS



WPA is pleased to announce our strategic partnership with International Society for Quality in Health Care (ISQua), which is a leading international organization dedicated to promoting quality improvement in health care. WPA & ISQua signed a Memorandum of Understanding (MOU) in 2022, which provides a clear framework of partnership between the two organizations. Through this partnership, WPA and ISQua strive to improve the quality and safety of patient-centred healthcare around the world. This framework includes activities such as information exchange, organizing joint projects, promoting, and participating in each other's activities and publishing joint statements on important healthcare issues



WPA also entered into partnership with World Federation of Public Health Associations (WFPHA), which is the only worldwide professional society representing and serving the broad field of public health internationally to have influence in the health of the people in today's globalized world. It represents over five million public health professionals worldwide. Both the organizations joined each other's organizational memberships as WFPHA has become WPA's corporate member whereas WPA has become WFPHA's partner membership.
