However, it was not approved due to objections raised by the United States. The draft resolution will now be resubmitted to the **UN General Assembly** for consideration and approval.

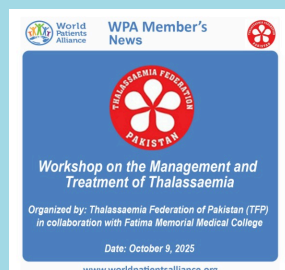
## Getting to Know WPA Team
